

# Beginner Trading Account

Terms & Conditions

---



## **1. Introduction**

- 1.1. The Beginner Trading Account Promotion (the "Promotion") is offered by Trading Moon (the "Company", "us", "we", "our", "ours" or "ourselves" as appropriate) regulated by the FSA in Seychelles and clients of Trading Moon who meet the Eligibility Conditions set out in paragraph 3 below (the "Client", "you", "your" or "yours" as appropriate).
- 1.2. You agree by participating in the Promotion that you will be bound by these terms and conditions and Trading Moon ordinary client terms and conditions (including, if any, schedules or amendments) that apply to your account and always subject to any applicable laws (together the "Terms").
- 1.3. All terms used that are not otherwise defined herein shall have the meanings ascribed to our ordinary client terms and conditions.

## **2. Promotion Period**

- 2.1. The Promotion starts on April 22, 2025 at 00:01 AM Seychelles standard time and shall remain active until cancelled by the Company (the "Promotion Period").

## **3. Eligibility Conditions**

- 3.1. To be eligible for this Promotion you need to:
  - 3.1.1. Already maintain a fully verified account or open a new fully verified account with the Company during the Promotion Period;
  - 3.1.2. Reside in a non-restricted country;
  - 3.1.3. Make a deposit of at least 100 USD during the Promotion Period (deposits over 2,000 USD will not be considered for the purposes of this Promotion); and
  - 3.1.4. Agree and comply with the Terms.  
collectively (the "Requirements").
- 3.2. Employees and their relatives, partners, or introducers of Trading Moon, or anyone associated with the Company is not permitted to participate in this Promotion.

## **4. Cashback Terms**

- 4.1. It is on our sole and absolute discretion to determine which customers who meet the Requirements can participate in this Promotion.
- 4.2. If the Requirements are met and subject to our approval, you will be eligible to receive a 20% cashback on net realized trading losses (the "Cashback"), credited to your real trading account.
- 4.3. The Promotion is available only to real accounts with leverage 1:200.
- 4.4. The Promotion is available only on the Moon Trader platform.
- 4.5. The Cashback applies only to net realized trading losses on trades executed in Major Forex Pairs, Gold, and Indices.
- 4.6. The Cashback is tradable, losable but not withdrawable. However, profits generated from the Cashback are fully withdrawable.
- 4.7. If you have multiple trading accounts, the Cashback will be credited to the account used for the first-time deposit.

- 4.8. Net realized trading losses are calculated weekly, from Monday to Sunday. Eligible Cashbacks are credited the following Monday. This process will repeat every week throughout the Promotion Period.
- 4.9. In order to claim the Cashback, you shall notify customer support.
- 4.10. Cashback previously issued and then lost in trading will not qualify for further cashback.
- 4.11. Cashback will not be paid on top of prior cashback that has been lost, to prevent any recursive rebate accumulation.
- 4.12. The Cashback will be available to trade with for 60 days following the credit of such Cashback in your real money trading account. If the Cashback is not used within the timeframe specified above, it will be removed from your trading account.

## **5. General Terms**

- 5.1. You can participate in this Promotion only one time.
- 5.2. You can participate in any other active promotion of the Company at the same time.
- 5.3. We shall have the sole and absolute discretion in determining whether the Cashback can be awarded to you or not. We further reserve the right to reject or withdraw the Cashback without prejudice if your participation is, or is likely to be, in breach of any Terms or any signs, or suspicions, that multiple accounts belong to the same customer or his/her immediate family.
- 5.4. Trading Moon reserves the right in its absolute discretion, to remove the Cashback from a customer's trading account and/or cancel the Loss Coverage with immediate effect, if there are reasonable grounds that the customer manipulated the Terms of this Promotion by, among other reasons, any form of arbitrage, hedging trading positions internally or externally, using any form of arbitrage or any other form of deceitful or fraudulent activity, or withdrawing the initial deposit and trading only with the Cashback, etc. Trading Moon accepts no liability whatsoever for any loss resulting from the stop-out of open positions after Cashback removal in accordance with these Terms.
- 5.5. We may in our discretion cancel or reverse the Cashback if a Cashback payment is made in error.
- 5.6. You agree to indemnify, defend and hold harmless Trading Moon (including its directors, officers, employees and assigns) on written demand and at all times from and against any and all liability, fines, penalties, actions, judgement, settlement, claims, demands, losses, damages, injury, compensation, costs and expenses (including interest payments, reasonable legal fees on a solicitor/client basis, other professional fees and disbursements and costs of investigation and litigation) for or in respect of which we will or may become liable by reason of or related or incidental to any act, default or omission and/or any breach of representation and warranty set forth herein by you under these Terms including without limitation resulting from or in relation to any breach, non- observance, act or omission whether negligent or otherwise.
- 5.7. To the extent permitted by law, your rights to litigate, to seek injunctive relief or to any other recourse to judicial or any other procedure in case of disputes or claims resulting from or in connection with this Promotion are hereby excluded, and you expressly waive any and all such rights.
- 5.8. If a Cashback payment cannot be executed as planned due to reasons beyond the control of Trading Moon, including but not limited to any technical problems or malfunctions, we shall not incur any liability to you in connection with the Promotion.

- 5.9. We reserve the right to change the terms of the Promotion or cancel it in its entirety at any time.
- 5.10. These Terms shall be governed by the a construed in accordance with the laws of Seychelles. The parties irrevocably agree that the courts of Victoria, Mahe shall have the exclusive jurisdiction to settle any dispute arising out of or in connection with this Promotion.
