

Refer a Friend

Terms & Conditions



1. Introduction

- 1.1. The Refer a Friend Promotion (the “Promotion”) is offered by Trading Moon (the “Company”, “us”, “we”, “our”, “ours” or “ourselves” as appropriate) regulated by the FSA in Seychelles.
- 1.2. You agree by participating in the Promotion that you will be bound by these terms and conditions and Trading Moon ordinary client terms and conditions (including, if any, schedules or amendments) that apply to your account and always subject to any applicable laws (together the “**Terms**”).
- 1.3. All terms used that are not otherwise defined herein shall have the meanings ascribed to our ordinary client terms and conditions.

2. Promotion Period

- 2.1. The Promotion starts on March 1, 2025 at 00:01 AM Seychelles standard time and shall remain active until cancelled by the Company (the “Promotion Period”).

3. Eligibility Conditions

- 3.1. To qualify for the Promotion, the person making the referral (the “Referrer”, “You”, “Your”, or “Yours” as appropriate) must:
 - 3.1.1. Have an existing verified real money account with the Company during the Promotion Period;
 - 3.1.2. Reside in a country permitted by our acceptance policy;
 - 3.1.3. Fund Your account with at least one deposit during the Promotion Period;
 - 3.1.4. Place at least 5 trades into Your real trading account during the Promotion Period. The trades shall be open for more than 3 minutes each; and
 - 3.1.5. Agree and comply with the Terms.
- 3.2. Any client referred by the Referrer to the Company under this Promotion (the “Referree”) must:
 - 3.2.1. Be genuine new client that opens a new fully verified live trading account (meaning, not a “demo” account) via the relevant link provided by the Company to the Referrer during the Promotion Period);
 - 3.2.2. Reside in a country permitted by our acceptance policy; and
 - 3.2.3. Place at least 5 trades into their real trading account during the Promotion Period. The trades shall be open for more than 3 minutes each; and
 - 3.2.4. Agree and comply with the Terms.
- 3.3. Employees and their relatives, partners, or introducers of Trading Moon, or anyone associated with the Company is not permitted to participate in this Promotion.

4. Reward Terms

- 4.1. It is on our sole and absolute discretion to determine which customers who meet the requirements can participate in this Promotion .

- 4.2. If the requirements are met and subject to our approval, the Referrer will be eligible for a reward (the "Reward") based on the below tiers:

# of referrals	Reward per referral
0-24	USD 10
25-50	USD 15
51+	USD 20

- 4.3. You can invite an unlimited number of friends. If the Rewards exceeds 1000 USD per calendar month, You will receive the exceeding amount on the next calendar month.
- 4.4. Should the number of referrals exceed 50 per calendar month, You will be eligible to become Trading Moon's brand ambassador (the "Brand Ambassador"). The Brand Ambassador shall receive the amount of 250 USD following our approval.
- 4.5. Should a Referee complete at least 1 trade during weekends, within 1 month from the day of their first trade, the Referrer shall be eligible for an additional 5 USD per eligible referral.
- 4.6. Should a Referee trade at least 5 asset classes, within 1 month from the day of their first trade, the Referrer shall be eligible for an additional 5 USD per eligible referral.
- 4.7. The Reward will be adjusted to the Referrer's account on a monthly basis on the second day of each calendar month. In the event that the second day of the month falls on a weekend, the adjustments will be moved to the subsequent business day. Once the Reward is adjusted, You will be able to withdraw it. The withdrawal method shall be the same as the method of Your deposit.
- 4.8. We will not charge You any fees for the withdrawal. However, the corresponding payment method may charge You according to their fee structure for which we are not liable.
- 4.9. The award of the Reward is subject to compliance with the Welcome Bonus Terms & Conditions by the Referee. For example:

If a Referee abuses the Welcome Bonus by withdrawing the initial deposit and trading only with the Welcome Bonus, the Referrer will not be awarded with the Reward for this specific Referee.

5. General Terms

- 5.1. You can only participate in the Promotion one time.
- 5.2. This Promotion can be used in conjunction with any other Promotion offered by us.
- 5.3. This Promotion is not designed to alter or modify an individual's risk preference or encourage individuals to trade in a manner inconsistent with their own trading strategies.
- 5.4. Clients should ensure that they operate their trading account in a manner consistent with their trading comfort level.
- 5.5. We shall have the sole and absolute discretion in determining whether the Reward can be awarded to You or not. We further reserve the right to reject or withdraw the Reward without prejudice if your participation is, or is likely to be, in breach of any Terms or any signs, or suspicions, that multiple accounts belong to the same customer or his/her immediate family.

- 5.6. Trading Moon reserves the right in its absolute discretion, to remove the Reward from a customer's trading account with immediate effect, if there are reasonable grounds that the customer manipulated the Terms of this Promotion or the general terms of business by, among other reasons, any form of arbitrage, hedging trading positions internally or externally, using any form of arbitrage or any other form of deceitful or fraudulent activity, or withdrawing the initial deposit and trading only with the Reward, etc. Trading Moon accepts no liability whatsoever for any loss resulting from the stop-out of open positions after Reward removal in accordance with these Terms.
- 5.7. If Your account is closed or suspended, we may cancel the Reward in your account, along with any profits made from this Promotion
- 5.8. We may in our discretion cancel or reverse the Reward if a payment is made in error.
- 5.9. You agree to indemnify, defend and hold harmless Trading Moon (including its directors, officers, employees and assigns) on written demand and at all times from and against any and all liability, fines, penalties, actions, judgement, settlement, claims, demands, losses, damages, injury, compensation, costs and expenses (including interest payments, reasonable legal fees on a solicitor/client basis, other professional fees and disbursements and costs of investigation and litigation) for or in respect of which we will or may become liable by reason of or related or incidental to any act, default or omission and/or any breach of representation and warranty set forth herein by You under these Terms including without limitation resulting from or in relation to any breach, non-observance, act or omission whether negligent or otherwise.
- 5.10. To the extent permitted by law, Your rights to litigate, to seek injunctive relief or to any other recourse to judicial or any other procedure in case of disputes or claims resulting from or in connection with this Promotion are hereby excluded, and You expressly waive any and all such rights.
- 5.11. If a Promotion payment cannot be executed as planned due to reasons beyond the control of Trading Moon, including but not limited to any technical problems or malfunctions, we shall not incur any liability to you in connection with the Promotion.
- 5.12. We may amend or discontinue this Promotion without any prior notice to current or prospective applicants and without having to compensate anyone for that.
- 5.13. If these Terms are translated into a language other than English, then the English version of the terms shall prevail where there is an inconsistency.
- 5.14. These Terms shall be governed by the a construed in accordance with the laws of Seychelles. The parties irrevocably agree that the courts of Victoria, Mahe shall have the exclusive jurisdiction to settle any dispute arising out of or in connection with this Promotion.
